However, as FastTrack is limited to displaying three decimal places, both times were automatically rounded to 30.022 in FastTrack, and as such no margin is displayed in FastTrack.</p> <p>In Range lost ground over the concluding stages of the event, underwent a post-race veterinary examination and was found to have right monkey muscle and right pencil/whip muscle injuries. A 5 day stand down period was imposed.</p> <p>Zodiac Bale underwent a post-race veterinary examination at the request of the trainer and was found to have a right fore split webbing.
