Fletchie Boy must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.

It was noted that the muzzle of Mystic Love became caught on the rug of Yelich during the running of the event.

Yelich underwent a post-race veterinary examination and was found to have a right long head triceps injury. A 7 day stand down period was imposed.

Mystic Love underwent a post-race veterinary examination – no apparent injury was reported.
