Race 11 SHIMA SHINE AT STUD 6:05 pm 425m Grade 5 T3	<p>A pre–race sample was taken from Hydro Glide.</p> <p>Button was quick to begin.</p> <p>Button (lost ground approaching the first turn) underwent a post–race veterinary examination and was found to have a left back muscle injury. A 21 day stand down period was imposed.</p> <p>Stewards spoke to Trainer Mr Kevin Ashton regarding Hydro Glide's racing manners approaching the winning post. Acting under the provisions of GAR 124, Hydro Glide was charged with failing to pursue the lure with due commitment. Mr Ashton pleaded not guilty to the charge. Hydro Glide was found guilty and suspended for 28 days at Bendigo and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>
Race 12 SPORTSBET BS RESPONSIBLY 6:30 pm 425m Grade 5 T3	<p>A pre–race sample was taken from Tinker Mate.</p> <p>Lektra Nick, Poison Sky and Blue Scotch Boy were quick to begin.</p> <p>Devil's Water underwent a post–race veterinary examination and was found to have a right triangle injury. A 21 day stand down period was imposed.</p> <p>Meeting Comments:</p> <p>The Stewards were advised that the track was medium harrowed on 24 June 2023.</p> <p>Satisfactory Trials:</p> <p>Back Moo Moo – Fail To Chase – Field of four, Distance: 425m, Weight: 28.7kg, Box 1, Placed: unplaced as greyhound pulled up. Back Moo Moo – Comment: Not Cleared as greyhound pulled up and tailed off.</p> <p>Back Moo Moo underwent a post–race veterinary examination and was found to have a left back muscle injury. A 10 day stand down period was imposed.</p> <p>Little Maldini – Unsatisfactory – Field of four, Distance: 425m, Weight: 31.3kg, Box 3, Placed 2nd, Time Run 25.64. Little Maldini – Comment: Not Cleared as greyhound did not met trial time standards.</p>
