#### Race 1

BENDIGO ADVERTISER (250+RANK)

6:44 pm 500m Maiden

Mcivor Roxy was quick to begin. French Quarter was very slow to begin (3 lengths)

Not Afraid (checked approaching the second turn) underwent a post-race veterinary examination and was

found to have left monkey muscle injury. A 14 day stand down period was imposed.

## Race 2

HIP POCKET BENDIGO (250+RANK)

7:08 pm 425m Maiden

Pursuant to GAR 75(6) Parade, Mr C.Blake did not act in any official capacity that may have in any way, affected the outcome of this event

Coomera Lad was slow to begin.

Coomera Lad (slow to begin and lost ground throughout the event) underwent a post-race veterinary examination and was found to have a left sesamoid injury. A7 day stand down period was imposed.

Stewards spoke to Trainer Mr B.Merton regarding Coomera Lad overall performance in the event. In accordance with GAR 122, the Stewards requested Mr Merton to report as soon as practicable anything that may have affected the running of Coomera Lad in the event, which was not noted by Stewards during or immediately after the event.

London Berry (turned its head inwards and collided with It's Luigi approaching the winning post) underwent a post-race veterinary examination and was found to have left sesamoid injury. A 10 day stand down period was imposed

Stewards spoke to Trainer Ms M.Berry regarding London Berry's racing manners approaching the winning post. Acting under the provisions of GAR 125, London Berry was charged with failing to pursue the lure with due commitment (by reason of injury). Ms Berry pleaded guilty to the charge, London Berry was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted

A post-race sample was taken from Artificial Blue - the winner of the event.

Hot Cross (severely checked Chasing Poppy approaching the home turn) underwent a post-race veterinary examination and was re-examined following race 7. Hot Cross was found to have abrasions to the left elbow. A 5 day stand down period was imposed.

Stewards spoke to Mr J.Uglietta regarding the racing manners of Hot Cross approaching the home turn. After hearing submissions from Mr Uglietta, viewing the available race footage and having their own observations, the Stewards issued a warning to connections regarding the greyhound's racing manners approaching the home turn

Luna Town (lost ground in the home straight) underwent a post–race veterinary examination and was found to have a right flexor tendon injury. A 10 day stand down period was imposed.

Mr Merton pleaded guilty to the charge, Little Winnie was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.

Marrying (turned its head inwards and made muzzle contact with Mibin Magic in the home straight) underwent a post–race veterinary examination and was found to have a left abraded paw. A 5 day stand down period was imposed.

Stewards spoke to Trainer Mr K.Ashton regarding Marrying's racing manners in the home straight. Acting under the provisions of GAR 123 Marrying was charged with marring. Mr Ashton pleaded guilty to the charge, Marrying was found guilty and suspended for 28 days at Bendigo and must perform a Satisfactory Trial/s in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.
