The race was delayed by approximately 24 minutes whilst this occurred. The race was rescheduled to commenced at 22:23.

Due to a failure with the lure drive system, the race meeting was abandoned at 22:26, pursuant to GAR 110 (4). All bets on greyhounds in the abandoned races are to be refunded in full. The weights recorded for the greyhounds in the abandoned races are void and do not count for the purposes of the weight rule at the greyhounds' next start.
