Stewards spoke to trainer Mr. A. Karabitsakos regarding Mumbo Cash's performance and racing manners in the back straight. After hearing submissions from Mr Karabitsakos, viewing the available race footage and acting on their observations, Stewards deemed the performance of Mumbo Cash unsatisfactory. Mumbo Cash must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted.</p>
