Jesse's Shout was found guilty and suspended for 28 days at all tracks and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted. Redeeming Lilly lost ground in the concluding stages, underwent a post-race veterinary examination and was found to have an abrasion on the left hindleg. No stand down period was imposed.
