Stewards spoke to representative Mr Darrell Leathan regarding Aston Rozee's racing manners in the home straight. Acting under the provisions of GAR 123 Aston Rozee was charged with marring. Mr Leathan pled guilty to the charge, Aston Rozee was found guilty and suspended for 28 days at all tracks and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.
