Stewards noted that there was no designated catcher for the greyhound, Supersonic Hawk. After an investigation of the matter, Stewards charged Ms. C. Brinsley pursuant to GAR 86(o), in that she did fail to catch the greyhound, which in the opinion of stewards was negligent. Ms. Brinsley pleaded guilty to the charge and was found guilty. Stewards issued a \$200 fine to Ms. Brinsley, which was inclusive of a previously suspended fine for a similar offence at The Meadows on 6th August 2014.

Enchanted Bling was vetted following the event. It was reported that the greyhound sustained an injury to it's right thigh and grazing to it's right front toe. A 5 day stand down period was imposed.

Mr. Ryder also observed that this was the first time the greyhound had raced over the distance at Sandown. Despite these factors, Mr. Ryder added that he had been very confident of the greyhound's chances prior to the race and had expected a forward showing. Stewards noted Mr. Ryder's comments and also directed that a sample be taken from the greyhound.

Major Missile was vetted following the event. It was reported that the greyhound sustained an injury to it's right back muscle. A 30 day stand down period was imposed.
