Dailly, Representative for Trainer of the greyhound, Lonesome Jozza. Acting under GAR 69(1), Stewards charged Lonesome Jozza with marring. Mr Dailly pleaded guilty to the charge, Lonesome Jozza was found guilty and was suspended for 28 days at The Meadows and directed that the greyhound perform a Satisfactory Trial, All Tracks, pursuant to GAR 69(2)(a) before any future nomination will be accepted.

Sisco Pure was vetted following the event and was revetted following Race 3. It was reported that the greyhound sustained an injury to the right triangle muscle, a 5 day stand down period was imposed. Stewards spoke to Mr A. Marum, Trainer of Sisco Pure. Acting under GAR 69(A)(1), Stewards charged Sisco Pure with failing to pursue the lure with due commitment. Mr Marum pleaded guilty to the charge, Sisco Pure was found guilty and was suspended for 3 months (All Tracks) and directed that the greyhound perform a Satisfactory Trial, All Tracks, pursuant to GAR 69(A)(2)(b) before any future nomination will be accepted.
