Acting in accordance with GAR 129 and being mindful of the safety of Aston Reina, other greyhounds in the race, staff and participants, Stewards were not satisfied with the performance and placed Aston Reina on a satisfactory trial under GAR 129, and pursuant to GAR 132, with the condition that Aston Reina must run and remain in the catching pen in order to pass the satisfactory trial, before future nominations will be accepted.
