<b>Race 2</b> SPORTSBET BET WITH MATES (250+RANK) 3:47 pm 390m Maiden	<p>Samuel Swan was quick to begin. Great Value and Turbo Brockie were slow to begin.</p>
<b>Race 3</b> NORFOLK BUTCHERS (250+RANK) 4:12 pm 390m Grade 7	<p>Deadly Ambition and Kumani Sapphire were slow to begin.</p> <p>Spin trailed the field throughout the event, underwent a post-race veterinary examination and was revetted following race nine. Spin was found to have a right monkey muscle injury. A 7 day stand down period was imposed.</p>
<b>Race 4</b> COAST FM & 3YB (250+RANK) 4:36 pm 390m Mixed 6/7	<p>It's Luigi was slow to begin.</p> <p>Speedy Quokka failed to pursue the lure with due commitment over the concluding stages of the event and collided with Hey Tootle.</p> <p>Speedy Quokka underwent a post-race veterinary examination and was revetted following race six. Speedy Quokka was found to have a left hamstring injury. A 5 day stand down period was imposed. Stewards spoke to representative Ms Jordan Mcquillen regarding Speedy Quokka's racing manners over the concluding stages. Acting under the provisions of GAR 125, Speedy Quokka was charged with failing to pursue the lure with due commitment (by reason of injury). Ms. Mcquillen pleaded guilty to the charge, Speedy Quokka was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>A post-race sample was taken from Madam Nova – the winner of the event.</p>
<b>Race 5</b> CASSIGN DESIGN (250+RANK) 4:57 pm 450m Mixed 6/7	<p>Zulu Ghost and Send It Blue were slow to begin.</p>

After hearing submissions from Mr. Walsh, viewing the available race footage and acting on their observations, it was established after being severely checked Saint Prue became unbalanced and collided with Ten Pineapples.
