After hearing submissions from Mrs. Barber, viewing the available race footage, and acting on their observations, Stewards deemed the performance of Zambora Riot unsatisfactory. Zambora Riot must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted.
