A 5 day stand down period was imposed. Stewards spoke to Mr Michael Callanan regarding Condor Avenue's racing manners approaching the winning post. Acting under the provisions of GAR 125, Condor Avenue was charged with failing to pursue the lure with due commitment by reason of injury.
