<b>Race 1</b> MACEY'S BISTRO (250+RANK) 2:50 pm 390m Maiden	<p>Lektra Daisy was quick to begin.</p> <p>Big Robbie trailed the field throughout the event, underwent a post-race veterinary examination and was found to have a left carpal (wrist) sprain. A 10 day stand down period was imposed.</p> <p>Lektra Hydro underwent a post-race veterinary examination and was found to have medial tibial periostitis on the left hind leg. A 7 day stand down period was imposed. Stewards spoke to Mr Philip Lenehan regarding the racing manners of Lektra Hydro soon after the start. After hearing submissions from Mr Lenehan, viewing the available race footage and having their own observations, the Stewards issued a warning to connections regarding the greyhound's racing manners soon after the start.</p>
<b>Race 2</b> SPORTSBET BET WITH MATES (250+RANK) 3:14 pm 390m Maiden	<p>Jetski Fund – New declared weight of 31.9kg last raced at 30.6kg.</p> <p>Jetski Fund trailed the field throughout the event, underwent a post-race veterinary examination and was re-examined following race 10. No apparent injury was reported. Stewards spoke to trainer, Mr Gary Hunt regarding Jetski Fund's performance. After hearing submissions from Mr Hunt, viewing the available race footage and acting on their observations, Stewards deemed the performance of Jetski Fund unsatisfactory. Jetski Fund must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>A post-race sample was taken from Black Bow – the winner of the event.</p>
<b>Race 3</b> NORFOLK BUTCHERS (250+RANK) 3:34 pm 390m Grade 7	<p>Oddball Armo was slow to begin.</p> <p>Deadly Ambition underwent a post-race veterinary examination at the trainers request and was found to have split webbing on the left hind paw. A 21 day stand down period was imposed.</p>
<b>Race 4</b> COAST FM & 3YB (250+RANK) 3:49 pm 390m Mixed 6/7	<p>Plenty Of Value was slow to begin.</p>
<b>Race 5</b> CASSIGN DESIGN (250+RANK) 4:10 pm 450m Mixed 6/7	<p>Don't Tell Benji – The frequency of racing was discussed with trainer, Darren Petersen, the comments were noted.</p> <p>Manson and Zulu Ghost were slow to begin.</p> <p>A post-race sample was taken from Great Value – the winner of the event.</p>

A 7 day stand down period was imposed.</p>
