A 7 day stand down period was imposed. Stewards spoke to trainer Mr. Paul Herry regarding Big Robbie's performance. After hearing submissions from Mr. Herry, viewing the available race footage and acting on their observations, Stewards deemed the performance of Big Robbie unsatisfactory. Big Robbie must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted.</p>
