Robertson did not act in any official capacity that may have in any way, affected the outcome of this event.</p> <p>Hey Wags was quick to begin. Queen Butterfly was slow to begin.</p> <p>Mr. M. Franklin was issued a warning under GAR 156(f) (negligence) for failing to catch Hey Wags at the conclusion of the race. In assessing the matter, Stewards took into consideration Mr. Franklin's record in the industry. It was reported that the greyhound was found to be injured in the cervico-thoracic region. A 10 day stand down period was imposed. Stewards spoke to Trainer, Mr. T. Dorrington, regarding the frequency of racing for this greyhound. Mr. Dorrington told Stewards it was his intention to spell Pinjarra Bale following the injury suspension.</p>

Stewards spoke to Trainer - Mrs. C. Roberts, regarding the racing manners of Aldren Bale in the home straight. Acting under the provisions of GAR 123, Aldren Bale was charged with marring. Mrs. C. Roberts pleaded guilty to the charge. Aldren Bale was found guilty and suspended for 28 days at Geelong and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted</p> <p>A post-race sample was taken from Rixi Bale the winner of the event.</p>
