Blazer Edition underwent a post-race veterinary examination and was found to have a right back muscle injury and left triangle injury. A 28 day stand down period was imposed. Call Me Thor was humanely euthanised. Following the running of this event, Stewards inspected the track turning off the back straight and deemed it satisfactory for racing.
