Race 1 SPORTSBET BET WITH MATES (300+RANK) 2:57 pm 500m Maiden	<p>Pursuant to GAR 75(6), Kennel Attendant, Mr Aaron Blake did not act in any official capacity that may have in any way affected the outcome of this event.</p> <p>Black Star Indi, Black Jester and Playmaker were slow to begin.</p> <p>Black Jester (turned it's head to the outside in the home straight), underwent a post-race veterinary examination and was re-examined following race 4 - no apparent injury was reported.</p> <p>Stewards spoke to representative, Mr Aaron Blake regarding Black Jester's racing manners in the home straight. Acting under the provisions of GAR 124, Black Jester was charged with failing to pursue the lure with due commitment. Mr Blake pleaded guilty to the charge. Black Jester was found guilty and suspended for 28 days at Bendigo and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>

Race 5 HANRAHAN PLUMBING (300+RANK) 4:22 pm 500m Mixed 6/7	<p>Rothwell Boy and Mr. Ha Ha were quick to begin. Millers Road and Linda Listen were slow to begin.</p> <p>Stewards spoke to trainer, Mr Jordan Formosa regarding the racing manners of Windy Buscuit in the home straight. After hearing submissions from Mr Jormosa, viewing the available race footage and having their own observations, Stewards took no further action.</p> <p>Linda Listen (faltered and lost ground approaching the first turn), underwent a post-race veterinary examination and was found to have a right back muscle injury. A 14 day stand down period was imposed.</p>

500m Grade 5	Call Me John and McIvor Jill were quick to begin. Pandorica (fell entering the back straight), underwent a post–race veterinary examination – no apparent injury was reported.
Race 7 MADE SOLUTIONS ELECTRICAL & DATA (300+) 5:05 pm 425m Grade 5	Shogub Warlord was quick to begin. Neil's Phoenix was slow to begin. Tilly Divine underwent a post–race veterinary examination at the trainer's request and was found to have a split webbing. A 14 day stand down period was imposed.
Race 8 GRAY'S BENDIGO (300+RANK) 5:30 pm 500m Grade 5	A pre-race sample was taken from Chanko Girl. McIvor Clyde was quick to begin. Jedda Milne was slow to begin. Jedda Milne (lost ground in the back straight and tailed off), underwent a post–race veterinary examination and was re–examined following race 12. Jedda Milne was found to have a right triangle muscle injury and a cervico-thoracic injury. A 21 day stand down period was imposed. A post-race sample was taken from Wichita Bale - the winner of the event.

Bucket Of Oil (severely checked on the home turn), underwent a post–race veterinary examination – no apparent injury was reported. Starchie (lost ground in the back straight), underwent a post–race veterinary examination and was found to have a left monkey muscle injury. A 21 day stand down period was imposed. In accordance with LR 40.2, Participant, Miss Kate Jackson was issued with a warning regarding non–compliance with the GRV Dress Standards. Stewards have opened and adjourned an inquiry into relation to a incident that occurred during kennelling in the wash bay.
