Sundance Ruby was found to be displaying erratic and unusual behaviours. A 10 day stand down period was recommended and imposed.</p> <p>Stewards then spoke to trainer Mr G. Johnson regarding Sundance Ruby racing manners throughout the race and the erratic and unusual behaviour post-race. After hearing evidence from Mr. Johnson, viewing the available race footage, having their own observations and assessing the veterinary report provided, the Stewards acted under the provisions of GAR 42 (1) (b) and prohibited Sundance Ruby from competing in an event until such time as both a veterinary clearance is provided to the satisfaction of Stewards and a Satisfactory Trial is completed pursuant to GAR 132. Further, in accordance with GAR 122, the Stewards requested Mr. Johnson to report as soon as practicable anything (further) that may have affected the running of Sundance Ruby in the event, which was not noted by Stewards during or immediately after the event.</p>

Global Charm (fell on the first turn) underwent a post-race veterinary examination and was found to have a right groin muscle injury and a right back muscle injury. A 28 day stand down period was imposed.

Cyclone Will raced ungenerously on the first turn and underwent a post-race veterinary examination - no apparent injury was reported. Stewards spoke to trainer Mr C. Dalton regarding the greyhound's racing manners. After hearing evidence from Mr. Dalton, viewing all the available race footage and acting on their own observations, Stewards took no further action. In arriving at this decision, Stewards took into heavy consideration the interference occurring to Cyclone Will's outside and the possible affect this incident would have had on the greyhound's racing manners on the first turn. Stewards were of the belief that the option to charge Cyclone Will for failing to pursue the lure with due commitment was open to them, but declined to do so in the belief that this would have been contrary to the intentions and the spirit of the rules.
