Stewards spoke to Trainer Mr G.Gledhill regarding Stack It On's racing manners on the home turn and in the home straight. Acting under the provisions of GAR 123, Stack It On was charged with marring. Mr Gledhill pleaded guilty to the charge. Stack It On was found guilty and suspended for 28 days at Bendigo and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.
