A 14 day stand down period was imposed. Stewards spoke to Mr Adam Richardson regarding the racing manners of Fireworks. After hearing submissions from Mr Richardson, viewing the available race footage and having their own observations, the Stewards issued a warning to connections.</p> <p>Grand Stride faltered approaching the winning post and lost ground, underwent a post-race veterinary examination and was found to have injuries to the right long head triceps and right quadriceps. A 21 day stand down period was imposed.</p> <p>Heather Blast faltered approaching the 50m mark, underwent a post-race veterinary examination and was found to have a right hindleg deltoid injury. A 7 day stand down period was imposed.</p>
