Horsham 27/7/2014.

Stewards today conducted an inquiry into the circumstances pertaining to the late scratching of Arvo's Echo. Stewards charged trainer Mr. George Arvanitis under GAR 86(o) in that he did fail to present the greyhound Arvo's Echo for it's engagement at Horsham on 27/7/2014, which in the opinion of stewards was negligent. Mr. Arvanitis pleaded guilty to the charge, Mr. Arvanitis was found guilty and fined the sum of \$200.00.
