<p><b>Race 8</b> CROYDON HOMING PIGEON CLUB 1:57 pm 350m Grade 5</p>	<p>An out of competition sample was taken from Ohana Brockie on 31/07/23 pursuant to GAR 139.</p> <p>Cyclone Will was quick to begin.</p> <p>Scarlett Express (checked at 300m mark and lost ground) underwent a post-race veterinary examination – no apparent injury was reported.</p>

After viewing the footage and having their own observations of the incident, the Stewards were comfortably satisfied that no greyhounds were advantaged or disadvantaged so as to affect the outcome of the Event. The All Clear was posted.</p>
<p><b>Race 10</b> HIGHWAY 31 MAIDEN CHALLENGE HT5 2:32 pm 300m Maiden Heat</p>	<p>Shake It Off was quick to begin.</p> <p>A post-race sample was taken from Judgement Day - the winner of the event.</p>
<p><b>Race 11</b> HIGHWAY 31 MAIDEN CHALLENGE HT6 2:50 pm 300m Maiden Heat</p>	<p>A sample was taken from Bernardo's Baby upon arrival at the course.</p> <p>Circle The Sky was slow to begin.</p> <p>Bernardo's Baby (turned its head to the outside approaching the winning post) underwent a post-race veterinary examination and was re-examined following event 12 - no apparent injury was reported. Stewards spoke to Mr B. Stockdale regarding Bernardo's Baby's racing manners approaching the winning post. Acting under the provisions of GAR 124, Bernardo's Baby was charged with failing to pursue the lure with due commitment. Mr. Stockdale pleaded guilty to the charge. Bernardo's Baby was found guilty and suspended for 28 days at Healesville and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>
<p><b>Race 12</b> SPORTSBET GO THE BLUE DOG 3:07 pm 300m Grade 5</p>	<p>Pursuant to GAR 75(7), Steward Ms D. Barber did not act in any official capacity for this event.</p> <p>Mighty Moose – New declared weight of 34.8kg, last raced at 36.3kg.</p> <p>Mighty Moose and Chop were slow to begin.</p> <p>Dundee Fidget lost ground approaching the winning post and underwent a post-race veterinary examination – no apparent injury was reported.</p> <p>Meeting Comments:</p> <p>Stewards opened and adjourned an inquiry with licenced participant Ms C. Wilson. Supplementary Advice - On 07 August 2023, Ms C Wilson was issued a official warning under GAR 93 (5), the matter is now finalised.</p>
