Acting in accordance with GAR 42(4), Stewards must receive a veterinary certificate of clearance that indicates the greyhound's vision is adequate to allow the greyhound to see the lure. Upon receipt of this clearance, Coulter Bale must then perform a Satisfactory Trial, pursuant to GAR 132, before any future nomination will be accepted.</p>
