Trainer, Mr. Jayden Cassar was fined \$100.</p> <p>Theodossi Bale and Man Of Courage were quick to begin. Celeste Bale and Lucky Jean were slow to begin.</p> <p>Daija Bale (lost ground over the concluding stages), underwent a post-race veterinary examination and was found to have a right carpal sprain. A 5 day stand down period was imposed.</p>

After hearing submissions from Mr. Gibbons, viewing the available race footage, and having their own observations, Stewards took no action.</p> <p>A post-race sample was taken from Bernardo Beast – the winner of the event.</p>

It was reported the greyhound was found to be injured in the right carpal and right flexor tendon. A 28 day stand down period was imposed.</p>
