Mr. Chapman pleaded guilty to the charge. Mighty Milo was suspended for 28 days at Ballarat only and must perform a satisfactory trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted. Mighty Milo was also ordered to wear an anti-aggression muzzle in all future events in accordance with GAR 131.

Lala Ultra Fast (marred by Mighty Milo and failed to finish) underwent a post-race veterinary examination and was found to have a small skin abrasion to the right forearm, no stand down period imposed.
