Acting under the provisions of GAR 125, Knockout Norm was charged with failing to pursue the lure with due commitment by reason of injury. Representative Ms Emily Azzopardi pleaded guilty to the charge. Knockout Norm must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p>
