Mr Edwards pleaded guilty to the charge and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted. Hany collided with Wally Wagtail following the 150m, underwent a post-race veterinary examination – no apparent injury was reported. Stewards spoke to Mr. John Lowndes regarding the racing manners of Hany following the 150m mark.
