Tornado Jack was slow to begin.</p> <p>Redemption Rock, underwent a post–race veterinary examination and was found to have a right shoulder injury. A 5 day stand down period was imposed.</p> <p>Stewards spoke to representative Ms S Bradley regarding Redemption Rock’s racing manners on the home turn. Acting under the provisions of GAR 123, Redemption Rock was charged with marring. Ms S Bradley pleaded guilty to the charge. Redemption Rock was suspended for 28 days at Ballarat and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Stewards spoke to name of trainer Mr H Goss regarding the racing manners of Pictor Natural.
