This matter was referred to the Club Manager for further consideration and remediation.

Crimson Kit was found guilty and suspended for 28 days at Geelong and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.
