Bomber's Lunatic was slow to begin. Mr Geoffrey Green failed to appear at the kennels by the appointed time to retrieve and prepare Bomber's Lunatic for racing. A warning was issued pursuant to GAR 97(2).

Dr. Linda May faltered approaching the home turn and lost ground, underwent a post-race veterinary examination and was found to have injuries to the right pencil muscle and right triangle muscle. A 10 day stand down period was imposed.

Race 7 SPORTSBET MAKE IT LOOK EASY 4:08 pm 395m Grade 5 T3	Bermuda Ben and Uno Peanut were slow to begin.
Race 8 ZACK MONELLI @ STUD 4:24 pm 450m Grade 5 T3	A sample was taken from Tutelina upon arrival at the course. Dr. Austin and Victory Boom were slow to begin.
<b>Race 9</b> NAK SIGNS 4:48 pm 395m Tier 3 - Grade 7	A post-race sample was taken from Dr. Evergreen - the winner of the event. Stewards conferred with the judges regarding the margin and finishing times for 3rd and 4th place between Master Eduardo and Swanky Ryker. A clear margin of a nose was visible in the photo finish image with the actual finish time for Master Eduardo being 22.7369 compared to 22.7373 for Swanky Ryker. However, as Fasttrack is limited to three decimal places, both times were automatically rounded to 22.737 and as such no margin is displayed in Fasttrack.
Race 10 MR AUDACIOUS @ STUD 5:04 pm 395m Tier 3 - Grade 6	Polar Teddy was slow to begin. Molly Supreme was galloped on in the back straight and subsequently fell, underwent a post-race veterinary examination and was found to have abrasions to the right front toes and left hind toe. No stand down period was imposed. Polar Teddy was severely checked in the back straight and lost ground, underwent a post-race veterinary examination and was found to have minor abrasions to the left and right hind. No stand down period was imposed. Due to a technical malfunction there was no split time available.
Race 11 HARD STYLE RICO @ STUD 5:28 pm 395m Grade 5 T3	Moraine Tom was quick to begin. Due to a technical malfunction there was no third split time available for this event.
Race 12 HOOKED ON SCOTCH @ STUD 5:44 pm 350m Grade 5 T3	A pre-race sample was taken from Next Teardrop. This event was delayed by approximately 4 minutes due to a minor issue with the linkages while moving the boxes onto the track. Sumerian was slow to begin. Spartans Fury underwent a post-race veterinary examination following an incident in the catching pen - no apparent injury was reported.

Due to a technical malfunction there was no second split time available for this event.

Meeting Comments -

Head Bin – In accordance with GAR 41(5), presented for a re–vet at the conclusion of kennelling as the greyhound was found to be injured at Traralgon (Satisfactory Trial) on 23 October 2023. Head Bin was examined by the On–Track Veterinarian and found to be free from injury. Head Bin was cleared to race. A sample was taken for analysis, in accordance with GAR 136.

Satisfactory Trial -

Drive Through - Blinkers On - Field of 4, Distance: 350m, Weight: 35.4kg, Box 4, Placed 1st, Time Run 20.39 – Comment: Cleared all tracks - cleared to race in blinkers.

Head Bin – Unsatisfactory Performance - Field of 4, Distance: 350m, Weight: 32.8kg, Box 8, Placed 4th, Time Run 21.35 – Comment: Not Cleared - faltered turning off back straight and lost ground. Head Bin underwent a post-trial veterinary examination and was found to have injuries to the right pencil muscle and right triangle muscle. A 28 day stand down period was imposed.
