Stewards took into careful consideration that Argyle Bell fell and collided with Going Gets Tough on the home turn, and the effect this incident would reasonably have had on the racing manners of Olivia Express and Argyle Emma. Subsequently, Stewards took no further action.

Following the running of this event, Stewards inspected the track on the home turn and deemed it satisfactory for racing.

One Spark (fell on the first turn) underwent a post-race veterinary examination and was found to have a left carpal sprain, a fractured toe on the right hind and right triangle muscle injury. A 60 day stand down period was imposed.

Dashing Robin (fell on the first turn) underwent a post-race veterinary examination and was found to have a left back muscle injury. A 14 day stand down period was imposed.

Due to the incident whereby One Spark and Dashing Robin both fell, neither greyhound can be seen in the Judge's photo finish for the event, as seen on Fasttrack. On live observation, Stewards and the Judge confirmed that both Dashing Robin and One Spark completed the course. The Judge and Stewards confirmed the placings acting on their own observations and available race vision - Dashing Robin (4th) and One Spark (5th).
