No stand down period was imposed. Stewards spoke to kennel representative Mr. John Clay regarding absolute Cooper's racing manners throughout the event. Acting under the provisions of GAR 125, Absolute Cooper was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Clay pleaded guilty to the charge. Absolute Cooper must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.
