Belair Ric was slow to begin.</p> <p>Stewards spoke to representative Mr M Mitchell regarding the racing manners of Inga Andie on the home turn. After hearing submissions from Mr M Mitchell, viewing the available race footage and having their own observations, Stewards took no further action.</p>

Saint Jayden and Jolly Roger were slow to begin. Arctic Bale went up with the lids at box rise and was slow to begin.</p> <p>Arctic Bale - raced greenly throughout, underwent a post–race veterinary examination and was found to have injuries to the right stifle, and the left and right quadriceps. A 14 day stand down period was imposed.</p> <p>A post–race sample was taken from Low Maintenance– placed third in the event.</p>
