Spring Tune (turned its head inwards and marred Kraken Turbo in the home straight), underwent a post-race veterinary examination and was found to have a right pencil muscle injury. A 7 day stand down period was imposed. Stewards spoke to Mr. M. Gibbons regarding Spring Tune's racing manners in the home straight. Acting under the provisions of GAR 123, Spring Tune was charged with marring. Mr. Gibbons pleaded guilty to the charge. Spring Tune is suspended for 28 days at Horsham and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>
