Stewards spoke to Mr Graeme Beattie regarding Rumour Not Fact's racing manners approaching the winning post. Acting under the provisions of GAR 124, Rumour Not Fact was charged with failing to pursue the lure with due commitment. Mr. Beattie pleaded guilty to the charge. Rumour Not Fact was suspended for 28 days at Warragul and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted. Mighty Lucifer raced ungenerously approaching the winning post, underwent a post-race veterinary examination - no apparent injury was reported. Stewards spoke to Mr John Brown regarding the racing manners of Mighty Lucifer approaching the winning post. After hearing submissions from Mr. Brown, viewing the available race footage and having their own observations, the Stewards issued a warning to connections. Jenna lost ground from the first turn, underwent a post-race veterinary examination and was found to have a right groin injury. A 7 day stand down period was imposed.</p>
