Little Ollie Mac - faltered and tailed off on the home turn, underwent a post-race veterinary examination and was found to have a dislocated or possibly fractured right hock. A 90 day stand down period was imposed.

Following to the running of this event, Stewards inspected the track in the vicinity of the home turn and found it suitable for racing. The satisfactory trials proceeded as scheduled.
