A 7 day stand down period was imposed.</p> <p>Mr. Daniel Hoch was fined \$50 for failing to ensure the registration card was produced for Little Speckle, pursuant to GAR 88.</p> <p>Bonnieville Icon was slow to begin.</p> <p>Little Speckle underwent a post–race veterinary examination and was re-vetted after race 3, and was found to have a left triangle injury. A 10 day stand down period was imposed.</p> <p>Stewards spoke to Mr. Daniel Hoch regarding Little Speckle's racing manners approaching the winning post. Acting under the provisions of GAR 123, Little Speckle was charged with marring. Mr. Hoch pleaded guilty to the charge. Little Speckle was found guilty and suspended for 28 days at today's track and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>

A 7 day stand down period was imposed.</p> <p>Stewards spoke to Ms. Sonia Murphy regarding Kaos Controls's racing manners approaching the winning post. Acting under the provisions of GAR 125, Kaos Control was charged with failing to pursue the lure with due commitment (by reason of injury). Ms. Murphy pleaded guilty to the charge. Kaos Control was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Stewards spoke to Ms. Sonia Murphy regarding the greyhound pulling up prior to the return gate and failing to enter the catching pen. After hearing evidence from Ms. Murphy, viewing the available race footage and acting on their observations, Stewards issued a warning.</p>

A clear margin of a nose was visible in the photo finish image with the actual finish time for Done The Best being 17.0486 compared to 17.0488 for Perfect Revenge. However, as Fasttrack is limited to three decimal places, both times were automatically rounded to 17.049 and as such no margin is displayed in Fasttrack.</p>
