Stewards spoke to trainer, Mr. V. Millington regarding Solar Lock's racing manners approaching the home turn. Acting under the provisions of GAR 125, Solar Lock was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Millington pleaded guilty to the charge. Solar Lock was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.
