Daisy Willow - lost ground turning off back straight, underwent a post-race veterinary examination and was found to have a left carpal sprain. A 7 day stand down period was imposed.  A post-race sample was taken from Fireworks – the winner of the event.  In accordance with LR 40.2, Mr M Bowerman was issued with a warning regarding non-compliance with the GRV Dress Standards.</p>

<p><b>Race 3</b> NORFOLK BUTCHERS (275+ RANK) 3:39 pm 390m Grade 7</p>	<p>The semaphore board incorrectly displayed "race 1" -  A pre-race sample was taken from Exotic Beauty.  Choice Moment was slow to begin.  Nimble Willow eased and turned its head outwards approaching the home turn.  Nimble Willow underwent a post-race veterinary examination and was found to have a spike wound to the left foreleg and soreness of the neck. A 7 day stand down period was imposed.  Stewards spoke to Mrs D Goudge regarding Nimble Willow's racing manners approaching the home turn. Acting under the provisions of GAR 125, Nimble Willow was charged with failing to pursue the lure with due commitment (by reason of injury). Mrs D Goudge pleaded guilty to the charge. Nimble Willow was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p>

Acting under the provisions of GAR 124, Dr. Dulcie was charged with failing to pursue the lure with due commitment. Mr K Quinn pleaded guilty to the charge. Dr. Dulcie was found guilty and suspended for 28 days at Warrnambool and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>
