Flying Speed (visibly eased approaching the winning post) underwent a post–race veterinary examination and was found to have bruising to the right hamstring area. A 5 day stand down period was imposed.

Stewards spoke to Trainer Mr Colin Goodman regarding Flying Speed's racing manners in the home straight. Acting under the provisions of GAR 124, Flying Speed was charged with failing to pursue the lure with due commitment. Mr Goodman pleaded guilty to the charge. Flying Speed was found guilty and suspended for three months all tracks and must perform two Satisfactory Trials in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.

Aaron Alpaca (faltered on the first turn and lost ground) underwent a post–race veterinary examination and was found to have a left wrist injury. A 14 day stand down period was imposed.
