Mr. Johnson returned to course and was issued with a warning.</p> <p>Shanlyn Rover (turned head outwards in the home straight) underwent a post-race veterinary examination and was found to have discomfort in the right shoulder and an abrasion above the front left wrist. A 10 day stand-down period was imposed. Stewards spoke to Trainer Colin Baker regarding Shanlyn Rover's racing manners in the home straight. Acting under the provisions of GAR 124, Shanlyn Rover was charged with failing to pursue the lure with due commitment. Mr Baker pleaded guilty to the charge.
