A 90 day stand down period was imposed.</p>

King Pop was slow to begin.</p> <p>Chappy's Girl (faltered approaching the first turn and tailed off) underwent a veterinary examination and was found to have a fractured right hock. A 90 day stand down period was imposed.</p> <p>Following the running of this event, Stewards inspected the track on the first turn and deemed it satisfactory for racing.</p> <p>This event was delayed approximately 3 minutes after greyhound Queen Butterfly slipped its lead en-route to the boxes and escaped from the control of Handler - Mr. K.Lloyd for approximately 20 metres before the greyhound could be caught. Queen Butterfly was vetted and passed fit to start. Following the event, Stewards spoke to Representative - Mr. K.Lloyd regarding the matter and fined him the sum of \$100 for negligence pursuant to GAR156(f). In assessing penalty, Stewards took into consideration, Mr. Lloyd's history in the industry and his first offence under GAR 156(f).</p>
