A 5 day stand down period was imposed.</p> <p>I'm Cheeky - racing manner home straight and underwent a post-race veterinary examination – no apparent injury was reported.</p> <p>Stewards spoke to Mr J Holt regarding the racing manners of I'm Cheeky in the home straight. After hearing submissions from Mr J Holt, viewing the available race footage and having their own observations, the Stewards issued a warning to connections.</p> <p>Vanessa Bale - racing manners home straight and underwent a post-race veterinary examination – no apparent injury was reported.</p> <p>Stewards spoke to Mr J Palma regarding Vanessa Bale's racing manners in the home straight.
