Acting in accordance with GAR 42(4), Stewards must receive a veterinary certificate of clearance that indicates the greyhound's vision is adequate to allow the greyhound to see the lure. Upon receipt of this clearance, Sure Slinky must then perform a Satisfactory Trial, pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Mr. M. Giddings was fined \$50 for failing to ensure the registration card was produced for Life's A Party, pursuant to GAR 88.</p> <p>Life's A Party and Little Splinter were quick to begin. Outlawed was slow to begin.</p> <p>Ultimate Eclipse (collided with Life's A Party turning off the back straight and lost ground) underwent a post-race veterinary examination, was re-examined following race six, and was found to have a thoraco-lumbar injury. A 7 day stand down period was imposed. Stewards spoke to Representative Mr. B. Smith regarding the racing manners of Ultimate Eclipse turning off the back straight.
