Acting under the provisions of GAR 123, Tangala Bale was charged with marring. Ms. Coleman plead guilty to the charge. Tangala Bale was suspended for 28 days at Traralgon and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.
