Acting under the provisions of GAR 123, He Is Chill was charged with marring. Mr. Jones pleaded guilty to the charge. He Is Chill is suspended for 28 days at Shepparton and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>

Acting under the provisions of GAR 125, Top Prairie was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Melville pleaded guilty to the charge. Top Prairie was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p>
