Very Unstable – Unsatisfactory Performance – Field of 4, Distance: 425m, Weight: 35.5kg, Box 2, Placed 2nd, Time Run 25.489 – Comment: Not Cleared, as the greyhound turned its head outwards and visibly eased on the home turn and again in the home straight.

Slander – Fail To Pursue/Blinkers On – Field of 4, Distance: 425m, Weight: 31.3kg, Box 6, Placed 3rd, Time Run 25.547 – Comment: Not Cleared as greyhound visibly eased and turned its head on the home turn.

Just Like Zuma – Fail To Pursue/Blinkers Off – Field of 4, Distance: 425m, Weight: 32.0kg, Box 8, Placed 4th, Time Run 28.386 – Comment: Not Cleared.

Just Like Zuma underwent a post-trial veterinary examination and was found to have a lumbo-sacral injury and a left psoas injury. A 14 day stand down period was imposed.
