Just Like Zuma underwent a post-race veterinary examination and was found to have injuries to the right back muscle and left monkey muscle. A 21 day stand down period was imposed. Stewards spoke to trainer Mr. Darren Petersen regarding Just Like Zuma's racing manners soon after the start. Acting under the provisions of GAR 125, Just Like Zuma was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Petersen pleaded guilty to the charge. Just Like Zuma must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p>
